

## 居留證變更起訖日申請書(存款帳戶郵寄專用)

## Application for Renewal of the Resident Certificate Validity Period (For Depositor Mailing Only)

If the application is not approved or has other unacceptable reasons, the Bank will notify the Applicant via the phone number or email address that was submitted by the Applicant.
